- **Individual Trustee Services** Life's Plan Inc. can offer families long term management of stand-alone 3rd Party Supplemental Needs Trusts and OBRA D4A Payback Trusts in providing supplemental services to individuals.
- **Successor Trustee or Special Trustee** as parents or other family members may pass on and often likely pre-decease the beneficiary. As Successor Trustee, Life's Plan Inc. can act as a non-profit agency to insure successful management and the long term success of a trust. Life's Plan Inc. has 27 years' experience to back your Special Needs trust/Individual trust in meeting the needs throughout each of our beneficiaries' lifetime.
- **Medicare Set Aside Trusts** and **other support trusts** for people with disabilities. Life's Plan Inc.'s trust expertise can insure proper handling of all the details in setting up, life care planning, and management to serve out the needs of a beneficiary even with non-traditional trusts like MSAs or other support trusts whereby the beneficiary may or may not be dependent on public benefit programs.

We work well with family fiduciaries and/or investment agents to manage the trustee aspects and duties of these very complicated trusts. ### Trust Administration Fees

- \$275 Enrollment fee (\$25 Life's Plan Inc./\$250 for initial legal review)
- 0.76% Trust Administration Fee (\$750 minimum charge per year)
- \$100,000 minimum required
- No termination fees
- If there is a request for extraordinary fees due to litigation, legal matters, or other extenuating time constraints there will be additional charges incurred to the trust. Your trustee will provide advance notice on any additional charges.

### Ancillary Fees *(not included with Life's Plan Trust Administration fees)*

- \$75 Annual Tax Preparation Fee
- 0.24% Custodial Services (Banker's Trust)
- 0.30% Investment Advisor Services (Fourth Street Performance Partners)
- \$25 For overnight mail delivery services

All new individual trusts documents will be reviewed by the Life's Plan Inc. legal staff to ensure that the trust documents meet all state and federal law requirements. Initial legal review fee can be waived based on quality of trust documents.
